

CAMPAIGN TERMS: “100 USDC WELCOME BONUS”

I. Campaign Organizer

Madison Six j. s. a., with its registered office at Slávičie údolie 106, 811 02 Bratislava, Company ID No.: 56 856 229, Tax ID No.: 2122476994, VAT ID No.: SK2122476994, registered in the Commercial Register of the Municipal Court Bratislava III, Section: Sja, File No. 381/B. The Company is a crypto-asset service provider (CASP) pursuant to Decision No. 100-001-025-273 of the National Bank of Slovakia dated 18 December 2025 under Regulation (EU) 2023/1114 (MiCA), on the basis of which the Company is authorised to provide services on a cross-border basis within the European Union (EU) and the European Economic Area (EEA) (hereinafter referred to as the “Organizer”). Crypto4me is the trade name of Madison Six j. s. a.

II. Campaign Period

The Campaign runs from 3 June 2026 to 31 December 2026 (inclusive), or until it is terminated early by the Organizer in accordance with these Terms (hereinafter referred to as the “Campaign Period”).

III. Conditions of Participation (Eligible Participant)

- Only a new client of the Organizer may participate in the Campaign. A new client means an individual over 18 years of age, a sole trader, or a legal entity that did not have a client account created or registered on the Organizer's platform before the beginning of the Campaign Period (hereinafter referred to as the “Participant”).
- Employees of the Organizer and persons closely related to them are excluded from the Campaign.
- Participation in the Campaign is voluntary. The Participant agrees to these Terms by taking the first action aimed at joining the Campaign (registration).

IV. Conditions for Receiving the Bonus

To receive the guaranteed welcome bonus of 100 USDC, the Participant must cumulatively complete the following steps, in the order set out below, during the Campaign Period:

- **Step 1: Account Creation** – Properly register on the website www.crypto4me.eu using the registration link designated exclusively for this Campaign, including providing all required registration details. A previously created account or an incomplete registration cannot subsequently or retrospectively be included in the Campaign.
- **Step 2: Identity Verification (KYC)** – Successfully complete the identity verification process and obtain approval as a client as part of the AML/KYC onboarding process in accordance with the Organizer's internal regulations and applicable law.
- **Step 3: First Deposit** – Make the first deposit of funds or supported crypto-assets (i.e. crypto-assets whose conversion or custody is supported by the Organizer and which are listed in the Organizer's Price List) into the client account in a minimum value of EUR 500 (or the equivalent of EUR 500 in crypto-assets, calculated on the date the deposit is credited).
- **Step 4: Trading (Minimum Trading Volume)** – During the Campaign Period, purchase, sell, or exchange crypto-assets exclusively through the Spot Trading Platform (the “Trading Platform”), with a total cumulative trading volume of at least EUR 5,000 or the equivalent amount in crypto-assets. Only successfully executed trades carried out through the Spot

Trading Platform count towards the required trading volume. Trades executed in any other manner, as well as the deposit referred to in Step 3, do not count towards the trading volume.

V. Bonus Amount and Crediting

The bonus amount is fixed at 100 USDC (USD Coin).

After all Campaign conditions (Steps 1–4) have been duly fulfilled, the Organizer shall verify their fulfilment within 30 calendar days from the date on which the final Campaign condition was fulfilled. The bonus cannot be paid in cash or in any other fiat currency to a bank account before it is credited to the Participant's crypto account.

The bonus will be credited automatically to the Participant's newly created client crypto account within the crypto4me service no later than 5 business days after the final condition under Article IV of these Terms has been duly and verifiably fulfilled.

VI. Rights of the Organizer and Campaign Abuse (Anti-Fraud)

The Organizer reserves the right not to credit the bonus where there is a reasonable suspicion of fraudulent conduct by the Participant (e.g. creating fictitious accounts, identity misuse, or circumvention of these Terms) or any other breach of the Organizer's General Terms and Conditions.

Each verified Participant may receive the welcome bonus only once, regardless of the number of accounts created, email addresses used, or repeated registrations. No entitlement to an additional bonus shall arise even if the original account is closed and a new account is subsequently created.

The Organizer reserves the right to amend these Terms or terminate the Campaign early at any time, particularly if the budget allocated to the Campaign has been exhausted or due to changes in the regulatory environment. The Organizer shall publish information about any amendment or early termination on www.crypto4me.eu. The rights of Participants who fulfilled the Campaign conditions before the amendment or termination shall remain unaffected.

VII. Personal Data Protection and Risk Warning

Personal data is processed for the purpose of fulfilling contractual obligations arising from this Campaign and the Organizer's statutory obligations under applicable law. Complete information on the processing of personal data is available on the Organizer's website under the Privacy Policy.

Risk warning: The value of crypto-assets may fluctuate rapidly and is subject to a high degree of volatility. Investing in crypto-assets may result in financial loss. USDC is a crypto-asset classified as an e-money token; however, holdings of crypto-assets are not protected by the deposit guarantee scheme in the Czech Republic.

VIII. Final Provisions

These Terms become valid and effective on the date of their publication on the Organizer's website, www.crypto4me.eu.

By participating in the Campaign, Participants agree to these Terms.

Legal relationships not governed by these Terms shall be governed by the Organizer's General Terms and Conditions and the laws of the Slovak Republic.

In the event of any disputes arising out of or in connection with this Campaign, the Participants and the Organizer undertake to resolve such disputes through mutual negotiations and agreement.
