Madison Six j. s. a. does not charge a separate fee for the exchange of crypto-assets.

The Company's remuneration for the services provided is included in the exchange rate (price) offered to the client in the form of a price differential (spread) between the buy and sell price of the crypto-asset.

The spread depends primarily on:

- the type of crypto-assets
- market liquidity,
- market volatility,
- transaction volume.

The client is always informed of the final transaction price before the transaction is executed.
