

SCHEDULE OF CHARGES AND FEES

Madison Six j. s. a. provides crypto-asset exchange and execution services at prices derived from the current market price of the relevant crypto-asset. Madison Six j. s. a. does not charge a separate fee for its services.

The Company's remuneration for the services provided is included in the exchange rate (price) offered to the client. The Company applies a mark-up to the price/spread obtained from the relevant exchange or execution venue, and the resulting price differential between the buy and sell price of the crypto-asset constitutes the Company's remuneration.

The spread depends primarily on:

- the type of crypto-assets
- market liquidity,
- market volatility.
